Firetrap Tag Stays On School

Official Says **Building Unfit** For Students

An official of the Ontario fire marshal's office Wednesday stated that St. Peter's Separate School in Sandwich South Twp. is not satisfactory for student occupancy.

John R. Bateman, of the engineering department of the fire marshal's office, made a two-hour inspection of the school Tuesday afternoon.

Although he did not elaborate on his findings, Mr. Bateman said he would file a complete report to his Toronto headquarters. A duplicate copy will be forwarded to the school board.

Mr. Bateman said there are two courses of action that could be taken by the board.

"They could either replace the structure with a new school or undertake certain structural changes and renovations to the present school," he said.

He did not state what changes and renovations would be necessary, but ad-mitted it would probably be an expensive undertaking.

The school is located on Highway 2 east of Lesperance Rd. It houses 85 students and has been labelled a firetrap by municipal officials. The students attending the school are from Maidstone, Sandwich East and Sandwich South Twp.

The structure is in two sections, the main being 56 years

"As far as combustibility is concerned, the school is about as bad as you can get," Mr. Bateman said.

The condition of St. Peter's The condition of St. Peter's School has been the subject of argument and criticism on the part of parents and municipal officials for several years. However, it was not until recently that the argument came to a head when sendwich Fast Council started. Sandwich East Council started a public controversy by calling the school a firetrap.

Since the Feb. 1 objection of Sandwich East, municipal officials met and outlined a course of action.

They decided to:

Immediately seek safer schools to accommodate the pupils temporarily.

Investigate costs and prob-lems of building a school on a site offered in Sandwich East

Twp.
Call for a ratepayers' vote
to provide the necessary approval for the purchase of a
site offered in Sandwich East

That meeting was held Feb. 6. Meanwhile, the students are continuing to attend classes in the controversial structure.

Old School Lives On

Residents Ask It Be Torn Down

OLDCASTLE - An old separate school section never dies; it simply fades away. And that likely is what will happen to R.C.S.S. No. 2, Sandwich South Twp., which was served by the old St. Peter's School.

That was the opinion of Richard Walker, township solicitor, who said the old school section board would live on, according to school statutes. Presumably the board ceases to function when all of the last-elected three members, have died members have died.

Paul Pelchat, chairman of the old trustee board, and Robert Leblanc, secretarytreasurer, appeared before Township Council to say that the old school was no longer a fire hazard. They had a letter from the Fire Marshal's Office indicating that this was the case because the building was boarded up and hydro disconnected.

Acting on a petition signed by 26 residents of the area, Council has asked that the school be dismantled.

Mr. Pelchat wanted to retain Mr. Pelchat wanted to retain the old school until the Department of Education had ruled on the union school proposal of old S.S. No. 2 with the new St. Peter's School in Sandwich East Twp. Mr. Walker said the proposal had been turned down.

"If the department turns down the union school pro-posal we will then get authority from it to tear the old school down. It will be down in three months one way or the other," said Mr. Pelchat.

Mr. Walker suggested that Township Council write the department, asking that Mr. Leblanc be notified that the union school proposal would not be entertained.

When supporters of the old St. Peter's School decided a new st. Peter's School decided a new building was necessary—following a series of articles on school safety in The Windsor Star—they disagreed on site. Two schools were built, St. Peter's in Sandwich East nad St. Mark in Maidstone Twp.

"The two groups got what they wanted," observed Coun-cillor Bert Baillargeon, of Sand-wich East Twp. "Let them now agree. The old school is an eyesore and it was I who helped condemn it."

Mr. Baillergeon said he was thankful to The Windsor Star for the action it took to help vacate the old building.

The Essex County Roman Catholic Separate School Board has accepted a bid of \$271,800 from A. Lombardo and Son Limited of Windsor for an addition to St. Peter School in Sandwich South Township.

The addition will be a combination resource centre and four classroom open concept area, a gymnasium and a separate kindergarten room. The accepted tender does not

include a public address system which will cost an additional \$4,524.

In other business, the board approved 11 contracts with individual bus operators totalling \$346,424 for the 1973-74 school year. In addition to the contracts, the board owns and operates 16 of its own school
