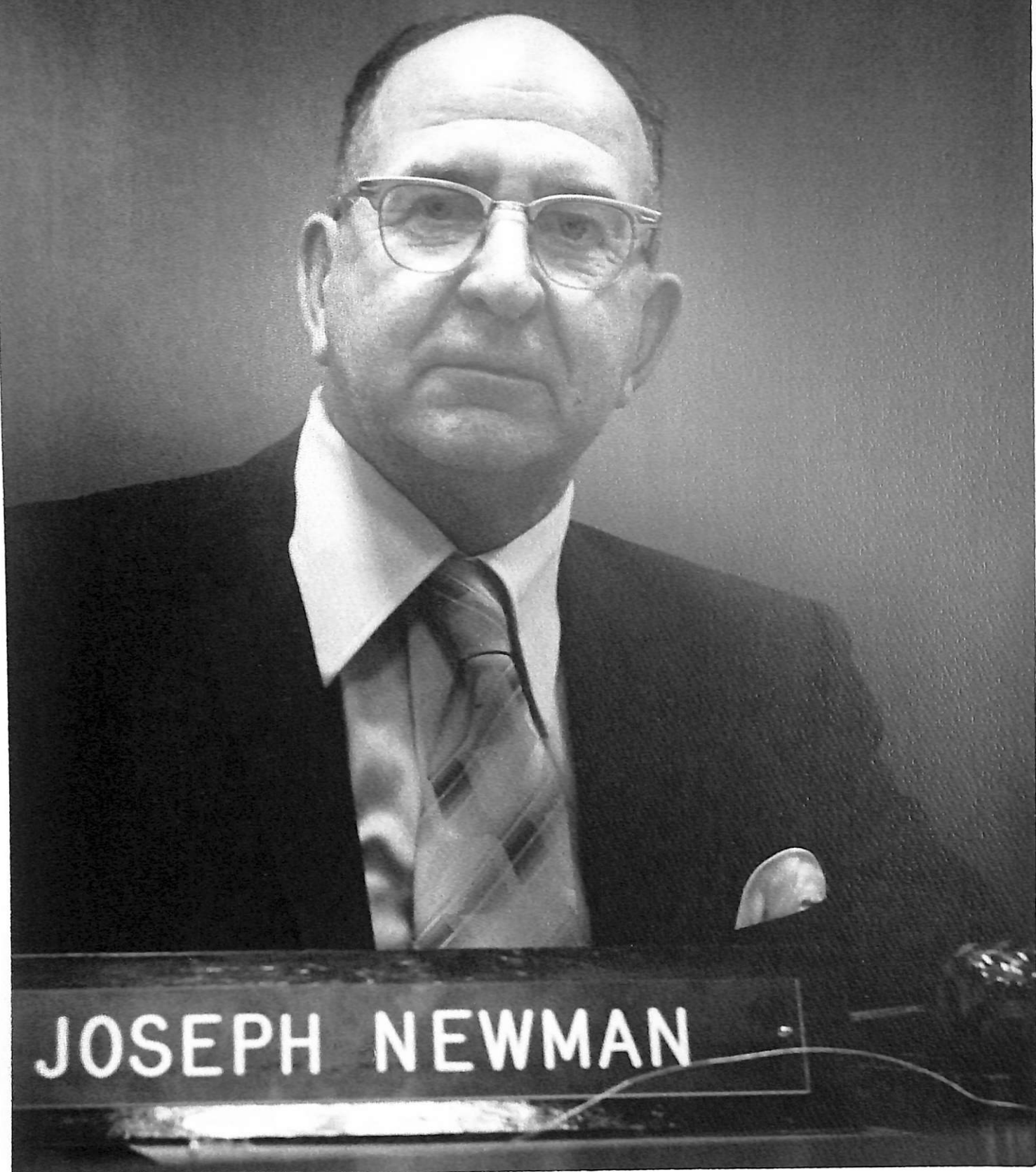

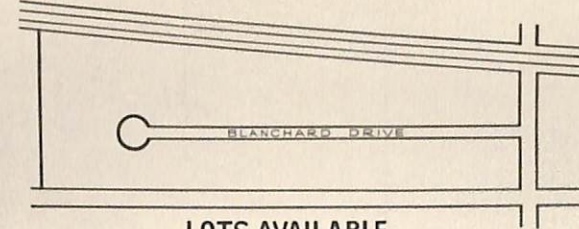

Dear Mr. Warden:

I want, on behalf of my wife and myself, to wish you the warmest and sincerest congratulations on being elected the warden of Essex County.

You have reached, as far as I am concerned, the highest position in municipal politics that there is, and it should only be a stepping stone to greater things, such as the next Minister of Municipal Affairs for the province of Ontario.

I think that you deserve special commendation on taking the part in public life that you do, because you have a busy life otherwise. Because by the very fact that you are so very busy in your business life, you have gained so much experience that it can only help you be a better administrator for the people of Essex County.

I like your stand on the fact that you feel local people should be having more say on what goes on in their community or their area. I have seen, and I am sure this is what bothers you most, the local authority gradually being taken away from the people by provincial authorities more and more all the time. Just three of the things that have really annoyed me are the way they have taken the Assessment Department, the jails, and the way they have told the county to assume old worn-out provincial highways. This completely contradictory to what good government should be, and by that I mean the local authorities can do a better job on the assessment program, they can do a better job on the jails, and the program as outlined to us regarding roads when I was a member of the County Council was that the province would gradually assume more provincial highways, and the county in turn would assume

more township roads and turn them into improved county roads. This will not be a possibility if the province continues to turn over old obsolete provincial highways for the county to maintain.

You no doubt are also aware, Bob, that I am appealing my assessment, not on the grievance that I am assessed too high, but on the fact that I think the people of Anderson and Malden are being discriminated against to such an extent that it should be brought to the public's attention.

We are going to the County Court on the 25th of January, and if not successful there, we intend to go to the highest court in the land. Even if we cannot be successful in terms of having money rebated to the farmers in Anderson and Malden, we intend to point out how unjust this assessment system is.

So much for all of my ideas--when all I really started out to do was to wish you the very best. I know you will enjoy the year. If you think there is anything I can do to be of assistance to you, please do not hesitate to call me.



Mr. Chairman, Reverend Sir, Friends, Fellow Members of the Essex County Council & Officials.

My term of office as your Warden is fast coming to a close, and soon will be past history like all other events that have happened in the year 1971, but will be a term and year of many happy friendships and occasions, and a period of my life that will not be forgotten by me or my family.

It seems no time since my inaugural ceremonies, when you chose me to be your Warden for the year 1971. Language is frequently inadequate when one undertakes to respond to such a great honour, as you ladies & gentlemen, my colleagues of the Essex County Council and Ratepayers of the County of Essex have shown me this evening, by being present at this banquet. I am proud and humble, and I fail to have words to express the measure of my happiness, sincerity, and humble thanks to you for having allowed me to as your Warden, the highest office in County Government, for the year 1971. It was indeed one of the ambitions of my career in public life.

During my career in public life, it has always been my endeavour to labour for the best of my local municipality and its ratepayers, as well as for the interest and welfare of the County as a whole. Throughout my career of serving the public, my heart was turned repeatedly to my ratepayers for their re-assurance, confidence, and support. Tonight in being honoured as the Warden of Essex County, is confirmation that I had the encouragement and the confidence on the part of the residents of the Township of Sandwich South, who are primarily responsible for my position, as your Warden, by electing me



their Reeve. I thank them for this privilege and for making this night possible.

Although my year is almost completed and the many events of a fully-packed year have all come and gone very quickly, each have had some historical importance, and I will cherish each one with fond memories of my experiences in public life, and the many friends I have made throughout the Province as I attended the many functions on your behalf.

In my capacity in serving as your Warden this year, I have received the full co-operation of all the members in all the matters brought before Council for their discussion and decisions; as well as the full co-operation of the Mayor and the City of Windsor Council Members and its officials in the joint projects discuss. For this I would like to express my sincere thanks and appreciation, by presenting the Mayor with this Scroll to hang in his office at the City Hall.

I would like to express my sincere thanks and appreciation to every Department Head and the members of their staff, and to all the News Media in Essex County, for their wonderful co-operation and assistance given to me during the year of 1971 which has made my year as Warden, most interesting, enjoyable, and educational.

The members of the 1971 County Council have had a challenging year, in their deliberations and decisions in making a reality and success the many projects operated on a County Basis during the year 1971 Sessions; such as-

a, For the Senior Citizens the County has on a County Basis opened 132 units in Essex, Amherstburg, Kingsville and Leamington for Senior Citizen Housing, and provide <sup>a for</sup> a new study <sup>to be made</sup> to determine the need for more housing to include housing in Tecumseh, Belle River, and Harrow; 13,000 applications have been sent out and O.H.C have told me this week already 400 applications have been sent in for more housing.

Addition to our Sunparlor Home of 53 additional beds will be provided.

b, For the relief of increased expenses to our local Councils and services at a joint meeting of Mayors and Councils we are now studying the possibility of joint purchasing and water grid.

c, For the needs of our mothers who are carrying on the load ~~of~~ <sup>at</sup> head of the household we are providing expanded Day Care Centres in Amherstburg, Leamington and Tecumseh.

d, Industry in the County which has a market value of 450 to 500 million dollars we have joined the Windsor Industrial Commission to provide industry with an outlet to advertise their products, plus keeping the investors posted to the potential of our commercial investment.

I will have to say the County Council has failed in the area of Agriculture.

We have at County Council sent resolutions to our Senior Governments as to:

Farm property tax. I know that our Farm tax payers resent the tax relief that is sent to them each year with strings attached. If property is over taxed there should be a change to the assessment on the property.



and County Council has told the Province this.

(B) As for farm prices. When I was in the Oldcastle Co-op the other day and seen a notice no more storage and corn at .90¢ and County Council had sent a delegation to Ottawa to talk to the Minister of Agriculture about prices.

I would say its about time our Federal members come out with a farm ~~Policy~~ for South Western Ontario, *as proposed in a brief to the*

Such as Elevator storage on the Norton terminals or at the Leamington or Kingsville dock area. Which in turn might induce other types of industry that will come here to locate if such a Elevator complex was built.

~~A~~ long hard look at the corn and cash crop price stabilization, *should taken by the Federal Gov't in this and all other areas affected.*

County Council are powerless when it comes to Agriculture and its about time we were heard.

The most important legislation that is now before you as heads of Councils and councillors is Conservation.

I was at a service not long ago When the minister talked of the role of elected representatives and he said:

We as ministers and priests are here to prepare us spiritually for the life beyond and you as elected representatives of the people are elected to provide for our well being on earth, that is "legislate for the future generations.

Well ladies and gentlemen that is what Conservation is about.

But the way our lake fronts are all bought up and now they are buying our wooded areas along our creek, marsh areas and streams are now being bought up what are we going to tell our younger generation, when they ask us where are our natural resources, such as nature and clean environment,

It will take two years to start a Conservation Authority and you will ruin it if we in future years ahead do nothing but buy back our resources and let the younger generations develop them, we have legislated for the future.

"Elected Officials" *Our younger generations future is in your hands, will it be a jungle of development and crime or one that you will want to live in, and your children will be proud to live in, knowing that you, as their parents and elected officials took the necessary action, when required, to improve and maintain the development of our County in a well planned manner.*

Honourable John Turner,

This meeting was requested by the Sandwich South Council with appreciation of M.P. Gene Whealan for getting us together here today.

The problem before us is the Windsor Airport grant-in-lieu of taxes which is paid each year to the Sandwich South Township.

A The Township of Sandwich South in 1968 passed a land use and zoning by-law which controlled development on lands adjacent to the airport properties.

1. that the Department of Transport gained benefits when the announcement of a major expansion of the airport was announced. Very little opposition was experienced.

The planning cost the township a considerable amount of loss in taxation; especially when one considers the area planned is adjacent to the City of Windsor and all utilities to service this property being at the boundary of the Township.

In the Official Plan two commercial properties of large acreage are across from the south-west corner of airport properties. ~~They~~ are subject to further controls in the last two years by the Department of Transport as to height and noise designation which has created a further tax loss.

*It could be argued if the airport was 3 or 4 miles from the prime location*

B The Sandwich South Fire Department have purchased equipment and have had training sessions geared with the possible disaster which may occur with all the aircraft landing and taking off. Our fire department portable water supply exceeds that of the City of Windsor - plus foam equipment, air packs and two fire halls; very close to the airport properties and very capable firemen.

C The highway and road network that service the airport terminal are Essex County Roads and Sandwich South roads.

*Don't cut off the money running off the road! ~~run in from the road~~  
additive cost to rate payers in connection to 40%*

D The manner in which the airport grants-in-lieu of taxes have been sent to the Township -

The first few years we received some of the grant money late in the year and the balance at the end of the year or in January or February of the next year. This created more expense due to borrowing on these monies for the operation of the Township and Essex County Levy.

In 1970, and 1971 the provincial assessment notices have been sent early in each year; no indication ~~from the treasurer to set the~~ mill rate of the township or monies anticipated, then late in the fall the treasurer of Canada cuts our grant; - in total a tax loss to the ratepayers of approximately 4 mills with the Township Council cutting back expenditures to be able to balance the books. Services are being cut back to the ratepayers.



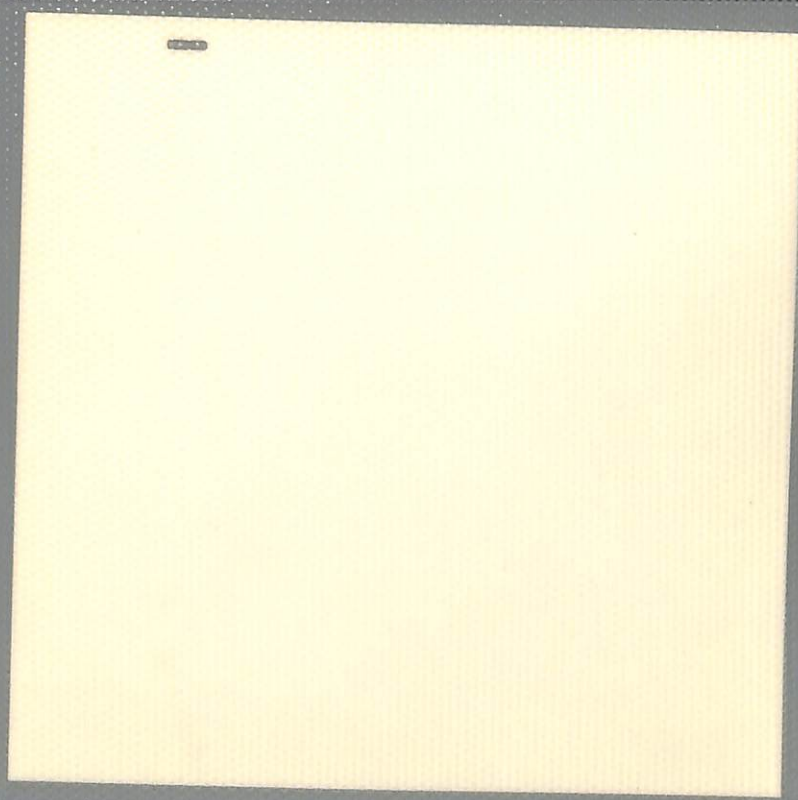




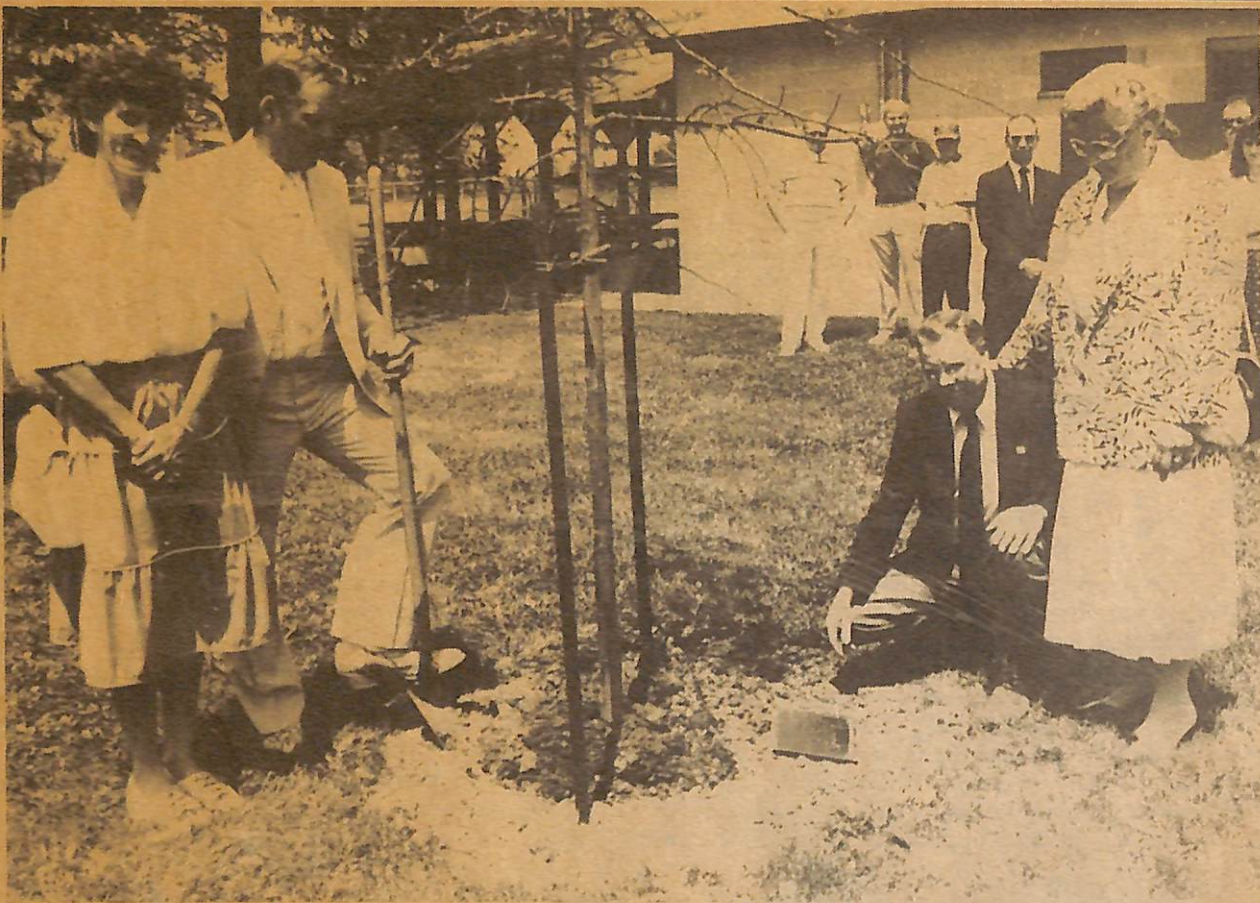

## Oak Reflects Man It Commemorates

An oak tree, planted in Weston Park was the best choice of tree to represent the character of the man

whose memory it was dedicated.

This was the tribute of former reeve of Sandwich South, Robert Pulleyblank,

to the township's former clerk, Bert Bedford.

The tree was planted Sunday in a memorial service at the park as a living memory of a man who served the township long and well by the township officials and the parks board.

After his retirement he continued to give his expertise to other municipalities as a consultant or to assist in the transition from one clerk to another. With more than 30 years for Sandwich South his years of service totalled more than half of a century.

He began his career with the taxation department and later took on the duties involved in planning for

adequate drainage. It was in this capacity that he served as consultant.

"This is a tremendous gesture to a person whose heart was in serving the municipality," said Reeve Allan Parr. "Everything was straight up with Bert. He was a real gentleman and a man with a fantastic memory."

Former clerk Evelyn Oliver, gave tribute for her opportunities with the township. She started as a part time typist. "I could never have gone on (to greater achievement) without his help. He taught me everything I knew about municipal government."

She, too, made reference to the oaks as a representative of Mr. Bedford.
